The CPEM Exhibition Committee extends an invitation to exhibit at the *2008 Conference on Precision Electromagnetic Measurements* scheduled for **June 8 - 13, 2008** at the **Omni Interlocken Resort** in Broomfield, Colorado.

The CPEM 2008 EXHIBIT and all technical sessions will be held in the same facility (Omni Interlocken Resort). The exhibition begins on **Monday, June 8th** and ends on **Wednesday, June 11th**. Booth Rental Rates and Description

All booths will be 10' wide by 10' deep. Each booth will be equipped with one 6' skirted table, two padded side chairs, one wastebasket, 3' high fabric siderails with 8' high fabric backwall and a 7" x 44" identification sign. The location for the CPEM 2008 EXHIBIT at the Omni Interlocken Resort IS carpeted.

Checks must be in U.S. dollars drawn on a United States bank and made payable to CPEM 2008. The deadline for full payment is April 1, 2008.

Decorator

Brede Exposition Services is the official decorator for the CPEM 2008 EXHIBIT and will provide the official exhibit service kit for the exhibit. The exhibit service will contain all necessary information required for ordering services from Brede Exposition Services and all other selected ancillary suppliers. Also included are any management materials such as event rules, information bulletins, etc. *Exhibit service kits will be made available online on April 1st, 2008.*

Exhibitor Registration

Each 10' x 10' exhibit booth fee includes one Full Conference registration, two Exhibit Hall Only registrations, and one Conference Digest. Full Conference attendees may attend all technical sessions and social events. Exhibit Hall Only registration includes admission to the Exhibit Hall, the Exhibitor's Reception and the Refreshment Breaks **ONLY**.

Additional company personnel are encouraged to attend. Individuals may attend as either additional Full Conference attendees or as "Exhibit Hall Only" personnel. Those wishing to attend CPEM 2008's technical sessions and social events must indicate Full Conference on the Exhibit Application & Contract Agreement (registration fees will be made available on the CPEM 2008 website at the beginning of January 2008). Companies will be invoiced for these additional Full Conference registration fees.

Any additional "Exhibit Hall Only" personnel must register for the \$75 rate on the Exhibit Application & Contract Agreement. This rate includes admittance **ONLY** to the Exhibitor

Cancellation

If written notice of cancellation is received by April 1, 2008, an administrative fee of 20% of the total booth fee will be retained. Cancellations after April 1, 2008 will result in forfeiture of the exhibit fee.
